SUB: New Motor Vehicle (Amendment) Act – 2019 – Reg.

Sir / Madam,

This is in continuation to the earlier communications issued by the Board with regard to Safety and Security of school children during transit in School Bus / Vehicles. In this connection, attention of all the Principals / Head of Institutions is hereby drawn to the **New Motor Vehicle (Amendment) Act – 2019** passed by the Central Government which is applicable across the country w.e.f. **01st Sep, 2019**. The features of this Act and main provisions for offences and penalties are as under:-

| Offence | Existing Penalty Rate (₹) | New Penalty Rate (₹) |

| Failure to use Seat (Safety) Belt | 300/- | 1000/- |
| Carrying more than 2 passengers on 2 wheelers | 100/- | 1000/- |
| Driving without helmet (on 2 wheelers) | 200/- | 1000/- and suspension of license for 3 months |
| Failure to allow free passage to Ambulance / Emergency vehicle | 00/- | 10000/- |
| Driving without license | 500/- | 5000/- |
| Driving despite disqualification | 500/- | 10000/- |
| Over speed driving | 400/- | 2000/- |
| Dangerous driving | 1000/- | 5000/- |
| Drunken driving | 2000/- | 10000/- |
| Using mobile while driving | 1000/- | 5000/- |
| Driving without permit | 5000/- | 10000/- |
| Driving uninsured vehicle | 1000/- | 2000/- |
| Driving vehicle by minor | 00/- | 25000/- and imprisonment for 3 years, cancellation of registration, vehicle owner and parents of minor will be held accused, non-issuance of license to the minor till the age of 25 years. |

As we are aware that in today's time, majority of the school children, who have not even attained the age of major / adult, are driving two wheelers for undertaking to & fro journey from school – residence – school. It has also been noticed that the children used to drive two wheelers without helmet / license, using mobile cell phones, over-speeding and dangerous driving. Thus, the **New Motor Vehicle (Amendment) Act – 2019** will cause irreparable loss to such students as in addition to financial penalty the student concerned may be imprisoned for 3 years followed by other consequential penalties.

Further, the above penalty clause also applies on the vehicles being utilized by the schools for transportation of children and the driver. It is therefore, requested that schools may take note of the **New Motor Vehicle (Amendment) Act – 2019** and make sure that the Driver of School Buses / Vans must comply with the Rules & Regulations to ensure safety of the children and to avoid any penalty. At the same time, schools are also requested to sensitize the children to not drive vehicle till they are minor.
